I, UWAMUTARA Claire am accusing the Rwanda government for the assassination of my husband and son on 01 July 2009 in Kigali-Rwanda.

Name: Uwamutara Claire. Father: Rusagara Antoine. Mother: Kibukayire Ancille. Last residence: Kigali urban. Commune: Nyarugenge.

Sector: Rugenge.

Cellule: Kabasengerezi.

I am member of Tutsi ethnic group and was married to NDAHIRO Danny since December 1996. My husband was also tutsi and member of RPF army (Rwandan Patriotic Front). He holds a rank of Cornel.

During the 1994 genocide, I went to hide in Saint Paul Parish until mi-June when RPF soldiers came to evacuate us. NDAHIRO Danny, at that time Lieutenant was commanding Bravo unit. All evacuated Tutsis were taken to REBERO hill. During that time, I was employed as nurse to help wounded people. Because of my work, I became known among soldiers. After the war NDAHIRO DANNY married me. I fled the country (Rwanda) on 01 July 2009 after the assassination of my husband Cornel NDAHIRO Danny and son NDAHIRO MAGNIFIQUE (9years) in morning around 4.00am occurred at our residence in KIGABAGABA village in KIMIRONKO in KIGALI - URBAN district.

It was around 4:00 am when NDIMUBANZI Francois heard people knocking at the main gate. He went there and found a military police convoy vehicle, registration number A980 R at the gate. The young man could identify one person in the name of SHAMAMBA FAUSTIN among other military officers in that vehicle.

Those Soldiers forced him to open the gate and were calling him stupid boy. He came back and told us what happened at the gate. I discussed for while with my husband and we thought there was a danger for us. We had fear and he told me to escape through behind house place. I left the house together with my 3children GIRAMATA CATHERTIA, GIRAMATA ANGE and IRADUKUNDA SALVATOR together with NDIMUBANZI François and UWINGABIRE AISHA. We tried to climb the fence so that we can leave the place quickly. Due to physical disability (result of torture in prison) my husband could not move with us.

We went to hide in the next house belonging to MAMAN DEBORA FRANCOISE spouse to GASPARD. While we were to MAMAN Debora's residence, we heard voice of my son MAGNIFIQUE NDAHIRO who left behind with his father crying the death.

NDIMUBANZI Francois and UWINGABIRE AISHA are hutu survivors picked on the war ground in Democratic .Republic of Congo by my husband. We are still living together because they could not yet identify their relatives.

SHAMAMBA FAUSTIN was known by our children because it was the second times to come to my home. The first time he came to arrest my husband because he was in disagreement with them on assassination plan of Hutus population among them NTILIVAMUNDA from GISOZI in KIGALI and KANZIRA ELDEBRAND from GITARAMA

After the 1994 genocide, KAGAME has created among military force, a group of soldiers with the mission to kill and eliminate all unwanted people mostly Hutus. That group of killers is known as GACURABWENGE which is a password to mean all group members. The commander of the team is Captain KATABARWA FRED. His office is located near RUBANGURA's house. They are paid but they do not wear uniforms. That group of killers kills many people every day. The majority of its members are soldiers from NKOLE – UGANDA and KARAGWE in TANZANIA. All tutsis who were residing in side RWANDA during the RPF war are assimilated to Hutus or INTERAHAMWE.

At that time my husband was chosen to be among the group as counselor together with Lt GAHIMA (dead from SIDA).

At his nomination, the group was given mission to identify people to eliminate mostly educated Hutus and other who; they think may oppose RPF regime. That task was done inside the country and outside countries especially in refugee's camps. During their first meetings, the agenda was the assassination of TWAGIRAMUNGU FAUSTIN, Pastor BIZIMUNGU and other Hutus dignitaries into the government. My husband has refused the plan to kill them. Later my husband was arrested on allegations that he was giving government secrets to TWAGIRAMUNGU. He served two months in KABINDI prison in KIMIHURURA –KIGALI.

The assassination of SET SENDASHONGA and LIZINDE was the plan of the same group. My husband refused the mission to KENYA to assassinate Set SINDASHOKA but later he was assassinated by KAJOLITE while LIZINDE by Sergeant MUNYANEZA Thomas alias LUKAMAYITI. MUNYANEZA is still working in Kigali at MINADEF (Defense Ministry).

The GACURABWENGE group organizes many meeting to plan killings of people. I remember the meeting at NOVOTEL Hotel on which I participated. (4June 2004) President KAGAME and Tito RUTAREMARA were also presents. Also ROZA KABUYE, TONI KURAMBA and others. I was invited in the meeting because I was a nurse at a hospital and they had to give us directive for the killings. Also because my husband was an officer in RPF army.

The agenda was to plan killings of people to come out from prisons, rich Hutus, educated Hutus and others unwanted people by KAGAME regime such as all members of HABYALIMANA army. During the meeting participants have been ordered to kill those people with all family members using all possible means. Discussions focused also on killing plan of BIZIMUNGU Pastor and Pierre Celestin RWIGEMA Premier Minister at that time. Also a white man working for International Amnesty (his name was Richard). The



say was that BIZIMUNGU Pastor was manifesting bad feeling on the current government so that he may disclose relevant information against it to international community. They considered him as a danger for the regime if is given chance to life. The white man called RICHARD was said to have full and true information on what was happening in RWANDA and the fear was that he may report on that to international community.

During that meeting, my husband asked to know why people have to be killed in such manner and requested from participants to think deeply on the aim of that meeting and its consequences on international level since there was no longer the war inside the country. Few participants joined openly his idea. Apparently the meeting was devided in two parts. After the meeting, my husband was also arrested.

His bodyguard called Gilbert came to my home to tell me that my husband is called for special mission. I will learn later from soldiers that my husband is jailed after 3 weeks. When I went to visit my husband at military police prison, he told me that he was invited into KAGAME house to explain himself why he is opposing killings plan. I learnt also that police commander EPHREM RURANGIRWA (former classmate in Tanzania) came also to visit him in KAGAME palace and my husband has refused to join the killers' team.

The killers group sent to our family a delegation from IBUKA and AVEGA-AGAHOZO and discussions was focused on my inviting and my husband for changing position so that we can join their killing plan. I remember SANGANO, FOEBIE, JULIENNE, BLANDINA and CLAUDINE among the delegation.

Their effort to convince us was not succeeded.

Later they have dismissed my husband from the team and the post was given to RWAKA SIMPLICE. That one is very active and killing many people every day.

After short period in prison, my husband was nominated into the Unity and Reconciliation commission. He has been asked to change his original name into SEBERA DAMASCENE so that no one could identify him easily. He worked there until 2007 when he was re-arrested. His re-arrest came after KAREGEYA Patrick failed his mission to assassinate Mr.KABUGA FELICIAN in Kenya. KAREGEYA PATRICK was sent to assassinate KABUGA after many others have failed. My husband was accused to have influenced cornel KAREGEYA PATRICK for not assassinate him. Cornel KAREGEYA PATRICK is known to have killed many people on KAGAME;s missions. His is actually in exile after having disagreement with KAGAME.

My husband's re-arrest occurred in December 2007 and he was in G2-prison (KIMIRONKO, (UMUSHUMBA MWIZA, 3rd avenue). It is underground prison. It looks like a residential area and the prison is located under ground. Apparently that house is belonging to Doctor GAKUBA because his family occupies the same house. The prison is not publicly known but is keeping many innocents lives.

Few days after his re-arrest, Lt UWAYEZU Fidel and Sergeant HABIYAREMYE OSWARD from military directorate accompanied by four military policemen came to see me on my way from C.H.K and shown me the arrest warrant paper. I was in the way from the hospital with my child who was sick. They asked me to look for someone to keep my

kid and I refused. They took me to prison together with my child. They took me at the same prison where my husband was. They tortured me using the hot liquid from plastic paper. They were putting that liquid on my foot finger's nails. They wanted me to give false testimony about the link between my husband and Hutus specially Hutu in outside the country and the reward we are expecting from them. They continued torturing me till they broke the bone of my arm. After torture they asked me to meet my husband and ask him why is betraying his country and what reward is expecting from Hutus. I met him but I failed to say anything to him except to ask him to be strong and keeping praying.

The person who was watching us said loudly that it impossible to make us vomiting the poison we ate from Hutus. After few days Cornel KAYONGA Charles came there and ordered them to allow me going to the hospital. They took me to Doctor Captain ALFRED (EX FAR-Hutu) and he made a successful operation by inserting a metal in the broken bone. After my operation, the doctor Captain ALFRED was also arrested on allegation that he healed my arm instead of cutting it of

I met him in MULINDI prison after my miracle transfer.

I spent two years in prison (till May 2009).

My husband remained into that prison until March 2009 when he was taken for rehabilitation exercises in KANOMBE Training Centre. He has become disabled because of torturing him.

I saw him again on 29June 2009 when he suddenly entered at home during evening times (Around 22:00). He told me that a military jeep dropped him at the gate. After two days on 1 July 2009, they came to assassinate him. My son died with him. It was in earlier morning around 4:00 am as I said in the beginning.

After his planed assassination, we waited for while to the neighbor and when we heard the military vehicle going, we came back home to observe what happened. We found in the house the piece of my husband's ear. We did not see bodies of my husband or son. They have been picked by killers. We feared to stay in the country and decide to flee through Uganda. We could not seek for asylum in Uganda because firstly Uganda was repatriating all refugees from Rwanda and secondary it is near Rwanda and I had all information about the killing plan of all refugees repatriated from Uganda. It is the same for all refugees repatriated from others countries. I know well their plan they will be killed through vaccination programs.

My husband NDAHIRO Danny was born in 1960 in BUTARE district, commune KIBAYI in LINDA village. His Father is NDAHIRO Michel and mother NYIRANTAGORAMA. He fled to Tanzania in 1961 with parents and they were settled in MWESI. He joined RPF when he was in exile.

After RPF took power in Rwanda, he worked under information department, in SADI-battalion and member of unit seven, served also under High Commandment (Presidential quards).

Lastly as I said, he served under Commission of unity and reconciliation although we met serious problems because of disagreement with current regime on killing of innocent people.

The strong points of his disagreement I may recall are as following:

1. In 1999-2000, KAGAME regime has planed genocide against Hutus.

I remember that Major RUSAGARA the commander of BYUMBA was killed also because he refused to give order to kill Hutus in that region. His death was attributed wrongly to Hutus rebels. RPF members who opposed the plan were called opposition members or just rebels. The man called SEBARENZI Joseph fled the country because of that There was a group to kill those Hutus. I may recall PIO MUGABO, Major ROSA KABUYE, SAM KAKA, KABAREBE JAMES etc.

The role of Pie MUGABO was to create chaos in all political parties. People who will oppose to him will be arrested on allegation that they have genocide ideology. It happened and people were arrested and killed.

Rose KABUYE has used his position as mayor of Kigali Urban to kill many people in Kigali.

His operation was so called ** town cleaning**. It was meaning elimination of Hutus and

all poor persons from the town.

She was also able to make false charges against unwanted person like to have link with Hutus rebels and preparing attacks against the country. People have been killed and others fled the country. She was using also the pick up vehicle to kill people by planed road accidents. Survivors were followed in the hospital and most of time they legs or arms were cut of to make them more suffering.

James KABAREBA was charged to clean the RPF army. It was meaning to kill all Hutus soldiers. I remember 5 military officers killed during a planed aircraft accident. Those officers were from the war in Congo.

All people who oppose the killing plan are jailed or killed. Corner KAREGEYA Patrick was implicated in killings. Later he refused to kill KABUGA Felicien in Kenya. He is in exile. Every body knows what happened to Major CYIZA. Rumors were saying that cornel HAKUZWIMANA Jean Damascene is dead but his in jail in G-2 and he became blind!

UWAYEZU Fidel, KAYIJUKA and CHRISTOPHE were in charge of killings of people from MULINDI prison.

The plan of killing was expanded even to Hutus in educational institutions (students) especially in BYUMBA, GISENYI, RUHENGELI and surrounding regions. After killings of their parents, killers were used to go to schools and pick even children. After elimination of all family members, it was said that children have followed their parents into exile.

KAGAME killers group follow people even beyond the border. Laurent NKUNDA is member of the same group. I know well NKUNDA I saw him during the killing meeting with KAGAME. During the meeting in URUGWIRO Village Hotel, he was present around 1999-2000. At that time discussions was focused on killing of hutus in Congo. I saw him again in 2004 at the office of High Commandment of military forces. I learnt from my husband that he came for military assistance.

At that time, my husband refused to sign for guns to be taken to DRC. He had a dispute with Adjudant MURENZI on that.



People say that Laurent NKUNDA is in prison in RWANDA but it is not the truth. He is kept in RWANDA because he holds very sensitive information about KAGAME killings in DRC and NKUNDA himself was following instructions from KAGAME.

In all those crimes, KAGAME do every thing to hide the truth on security situation in RWANDA. For example journalists are ordered to produce false voices for people already killed.

Another issue of hiding the true is concerning genocide cases proceedings in Arusha courts. Witnesses for accusation are taught what to charge even for unknown accused. The prosecution side provides photos for the accused and the text is produced for the witness. It is like drama game. People who refused testify through such conditions are seriously punished (they became prisoners without files, forced into exile or killed).

Stories of KAGAME regime killings are very sad and many. However reasons of my husband assassination are the following:

1. To oppose genocide of Hutus.

2. To oppose the planed assassination of Pastor BIZIMUNGU,

3. To oppose the elimination of all educated Hutus,

- 4. To oppose the assassination of RICHARD; a white many who was working for international Amnesty. During his escape from Rwanda to Uganda. MUNEZERO Chris; a member from RPF intelligence followed him in the bus. He managed to inject him sleeping medicine and he stolen his laptop computer and other important documents.
- To oppose the killing plan during NOVOTEL Meeting. They tried to convince him for joining the plan, and even they gave promise to take his all family in Ethiopia if any problem but my husband has refused to commit such crime.
- 6. To oppose false testimonies especially from genocide survivor's assassination (Tutsis). The idea was to give freedom to tutsis survivors of genocide to give false testimonies against hutus and be accepted as the truth.
- To refuse the assassination of NTILIVAMUNDA said to be a brother to former President HABYALIMANA. That person still in life in Rwanda-GISOZI and can witness that.
- 8. To oppose the plan of killing, using vaccination of foolishness of all ex-soldiers from the former President HABYALIMANA. Charles MULIGANDE who opposed the same plan has been beaten by KAGAME himself during the meeting. Media has even written on that incident.

All those reasons are behind imprisonment of my husband and finally to his assassination on 01/07/2009, few days after his release from the prison on 29June 2009. His spirit rests in peace.

I would like to be given a chance to accuse the RWANDA government for the assassination of my husband and son as well as temptation to kill my self and the remain family members

I decided to flee the Rwanda because they wanted to assassinate myself together with my husband.



I am fleeing the government full of criminals and which is forcing people to join their killing plan.

The death of my husband and son is the proof.

I would like to put all those proofs in writing but I want to be ensured of my protection because I know that those killers are behind me and I have seen them moving around in Dzaleka camp.

I completed my secondary education in 1996 and got married in December 1996. We made legal weeding at NYRUGENGE Commune.

I found a job without complication because my husband was trusted in the regime. I was also trusted and my work, as nurse was to treat diseases from high military officers.

Later I have been transferred to KIMIRONKO Hospital and frankly I realized that it was to probe me deeply.

I say so because I have been given very difficult tasks including the following things:

- 1. To assassinate soldiers originated from HABYALIMANA regime using medicine (overdose or poisons).
- 2. To assassinate their wives and babies during deliveries.
- 3. For a Hutus survivor from road accident, to cut of immediately legs or arms even those not seriously affected or wounded.

I sincerely failed to obey the order and it valued me the transfer to MUHIMA prison known as 1930.

There I found very serious diseases among because they were staying in salted places. Everyone has to keep stand up in container where they have put a bag of salt! I got foolish to observe such terrible things.

They were also voluntarily shortage of medicine. Only panado and bruffen was given so that it was difficult to heal those people with swollen legs. Prisoners were seriously beaten every day.

I cried out till the Red Cross and other humanitarian agencies were aware of that critical situation.

Tutsis were not happy because of my help to those prisoners' hutus. A woman called TRIFONIA (tutsi) accused me and the Tutsi survivors association invited me for explanations. I openly told them that I learnt to heal people and not to kill them. They said that they will kill me.

Few days, they put me in prison but because of my husband they have released me. My husband was advised at several occasions to abandon me for marring another wife to whom they were together in exile but he refused.

Back from prison, they nominated me to work at KICUKIRO Health Centre. At the new place of my work I have also given directives. To reduce the number of Hutus babies by death and to give mother complications by inserting metal or other dangerous thing like scissors inside before closing his stomach. The order was that in 100 maternity cases. 30 mothers and 20 babies have to die.

I failed again to obey it because all those babies and mothers have not committed any crime against me. One woman was very active in obeying the order: ASTERIA is committed to kill every hutu. I think she is working for Satan at KICUKIRO healthy Centre and she is paid day and night.



I have applied to stop working so that I can continue studies but they refused by giving me transfer to RUGWIRO Health Centre. My workmate was AKAYEZU. There I was giving medicine in prison GAKO-I KAMI. Prisoners were seriously tortured using liquid from plastic subjects such as jerry cans. We have given also directives to give unknown vaccination to patients including giving blood with SIDA. It was vaccinations to kill prisoners and many have died.

I felt tired to see innocents people dieing and felt guilty before the God and so decided

to stop the work again.

After that, I was again accused to ignore and oppose government directives. I have been re-arrested and put in prison. They tortured me using hot plastic liquid. I had an open fracture of arm bone and my foot finger's nails are burn. I will remain in prison till 2007.

I became disabled. Few days after my husband was also arrested. He will remain in prison until 29-06-2009. As I have said my husband was assassinated on 01-07-2009.

I learnt that his body was found in CYANGUGU District.

What I am requesting from MALAWI government is my protection.

I know well that there is a plan to repatriate by force all refugees to RWANDA.

My knowledge is that most repatriated refugees to RWANDA will die in few days. The government has organized a plan to kill those people using vaccinations and poison. I know it because was a nurse and I know the hall practice.

I am insisting on my security in MALAWI because I sow two men from RWANDA who I

think were behind me. Those are RWAKA and GATETE.

I am crying for help for:

- 1. People who are still dying in C.H.K, in hall number 7. They are cutting on mercy their legs and arms. Hutus are finishing in all halls of the hospitals.
- 2. In Intensive care hall, there is a Sister (disabled leg) who is killing many Hutus.
- 3. Students who are stolen in schools to be killed together with their parents.
- 4. All Tutsis who refused to join the government killing plan or to give false accusations against Hutus. Those Tutsis are seen as enemies of the country. They are put in prison and even killed.
- 5. Accusing Captain KIYAGO who killed my 2 sisters to end dispute on houses in NYAMIRAMBO. He is actually free and committed to kill survivors in my family.
- 6. Accusing KAGAME, President of RWANDA and his killers of innocent people.
- 7. Helping to determine my future together with my remaining children. We are no longer appreciated among Tutsi community and can not be appreciated among Hutus. We do not know where to belong.
- 8. Recovering my properties: money, 2minibuses, Randcruiser, spacior family car and Prado, 4houses in NYARUTARAMA, KIGABAGABA and NYAMIRAMBO.

- 9. Helping my family members in prison: NDANDAYIRE Chantal and Sergeant RUGWIRO Method.
- 10. Protecting the family which is helping me in Malawi because my presence in this family may cause insecurity to them.
- 11. Giving equal opportunity to all Rwandan groups to participate in country politics so that the can have access to justice. Justice is in the hand of corruption in Rwanda.
- 12. Requesting countries hosting refugees from Rwanda to give more attention on requests by Rwanda governments in term of refugees' repatriation especially during 2009 and 2010. Their plan is to force repatriation by giving money to host countries and humanitarian agencies such UNHCR so that they kick out every refugee.

13. Helping international justice to judge all members of killing group in Rwanda.

Actually estimated at 3600. Those people are granted asylum in Ethiopia and Eritrea. Few of them have gone there and they are called BANYAMURENGE from D.R.C.

14. Calling for justice in favor of Captain ALFRED arrested on allegation that he operated successfully my arm. I do not know another name but he was married to the Daughter of Victoria NGANYIRA, Ex-journalist of Radio Rwanda.

15. Calling for help to people in prison who are being beyond tortured mostly using the liquid from plastic Jeri cans.

I declare that all information I disclosed in this document are corrects and I am ready to provide more explanations and details to anyone wants to know better on security situation in RWANDA.
